SAC CIVIC BALLET PRE-PROFESSIONAL COMPANY REQUIREMENTS

- Fulfill class level requirements to include:
 - Sac Civic Ballet Company Class (*counts as technique*)
 - Thursday 4:30pm-6:00pm
 - Saturday technique class, 11:00am-12:30pm
 - 2 additional technique classes
 - 2 pointe classes
- Attendance at scheduled company rehearsals (*see schedule*)
- Required performances/events (attendance at additional rehearsals required)
 - Nutcracker/Christmas Angels: December 20 & 21, 2025
 - RDA Festival Adjudication: TBD (likely January/February 2026)
 - RDA/Pacific Festival in San Diego, CA: April 9-11, 2026
 - Spring Ballet Performance: TBD
 - Level testing: TBD
 - Showcase: TBD

 - Nutcracker/Christmas Angels: December 20 & 21, 2025
 - RDA/Pacific Festival in San Diego: April 9-11, 2026
(*Not required but highly encouraged)
 - Spring Performance: TBD
 - Showcase: TBD
- Company fees are an estimated \$350/year. Discounted company Tuition is \$335/month for unlimited classes. Fees associated with RDA/Pacific Festival have not been published yet but payments to start in October 2025 if you will attend
- Family involvement in company hosted events and performance productions

CROCKETT-DEANE BALLET PETITE COMPANY REQUIREMENTS

- Minimum 3 classes per week to include:
 - Tuesday level 4/5 technique class
 - 2+ additional technique classes (stretch/tap/contemporary/modern does not count)
 - Tuesday Petite Company Class (Free - does not count as technique)
- Required performances/events (attendance at rehearsals required)
 - Nutcracker/Christmas Angels: December 20 & 21, 2025
 - Spring Performance: TBD
 - Showcase: TBD
