SAC CIVIC BALLET PRE-PROFESSIONAL COMPANY REQUIREMENTS

- Minimum 6 classes per week to include:
 - 2 pointe classes
 - 2 additional technique classes
 - Thursday 4:30-6:00 & Saturday 11:15-1:00 Sac Civic Ballet Company Class
- Attendance at scheduled company rehearsals
- Required performances/events (attendance at additional rehearsals required)
 - Nutcracker/Christmas Angels: December 21 & 22, 2024
 - RDA Festival Adjudication: TBD (likely January 2025)
 - RDA/Pacific Festival in Mountain View, CA: March 19 - March 23, 2025
 - Spring Performance: May 17 & 18, 2025
 - Level Testing: May 26 - June 3
 - Showcase: June 7, 2025 (Date subject to change)
- Company fees are \$350/year. Discounted company Tuition is \$350/month for unlimited classes. Fees associated with RDA/Pacific Festival have not been published yet but payments to start in October 2024.

- Required performances/events (attendance at rehearsals required)
 - Nutcracker/Christmas Angels: December 21 & 22, 2024
 - RDA/Pacific Festival in Mountain View, CA: March 19 - March 23, 2025
*(*Not required but highly encouraged)*
 - Spring Performance: May 17 & 18, 2025
 - Level Testing: May 26 - June 3
 - Showcase: June 7, 2025 (Date subject to change)
- Company fees are \$325/year. Discounted company Tuition is \$325/month for unlimited classes. Fees associated with RDA/Pacific Festival have not been published yet but payments to start in October 2024 if you will attend

 - Spring Performance: May 17 & 18, 2025
 - Level Testing: May 26 - June 3
 - Showcase: June 7, 2025 (Date subject to change)
